Mr. Botts received his Bachelor of Arts degree in Political Science from St. Mary's University and Master of Security Management from the University of Houston Downtown. After serving for 31 years in the U.S. Department of State as a Foreign Service Officer (Santo Domingo, Seoul, Dublin, and Nassau), Assistant Director of the Houston Passport Agency, and an Information Systems Security Officer, Mr. Botts retired and went to work in the private sector as a consultant for Swailes & Co. Inc. specializing in cyber security, risk management, business continuity, due diligence, travel security, and investigations. During his federal career he served as Program Chairman of the Gulf Coast Federal Safety Council, and as a member of the Federal Executive Board. Mr. Botts is a founding board member of the Foreign Policy Alliance and has spoken on foreign policy issues to civic groups, colleges, and the media. In the cyber security community, he sits on the Secure World Advisory Council, and participates in the UN Internet Governance Forum.

Cyber Warfare (Fall 2016, Spring 2018, Spring 2019, Spring 2020, Spring 2022)

This course examines the growth and scope of cyber warfare as it impacts national power in the realms of government, diplomacy, international law, international commerce/economic power, social media/privacy, science and technology, and civil society. It traces the evolution of conflict from traditional information gathering to the development of cyber weaponry with destructive capabilities and the use of those capabilities to advance national foreign policy interests. Through the use of case studies and selective readings from a variety of sources (government policy directives, cyber security industry studies, and defense related academic papers) the course guides students through the emergent quality of the broadening scope of cyber conflict and the multifaceted response to the challenge. Ultimately students are confronted with the impact of the ongoing threat as they interface with cyberspace in their day-to-day interactions. The goal is for a deeper understanding of the scope and complexity of the cyber domain and the global conflict that is raging out of view.

Introduction to Enterprise Cybersecurity (Fall 2021, Spring 2022)

This course takes an enterprise level holistic perspective of cyber security. The purpose is to explore the emerging threat landscape and the means through which organizations both private and public develop and employ various cyber security policies, procedures, and tactics in response. It evaluates the various cyber security tools, structures, and protocols that serve as best practices within industry, by governments, and international organizations. It examines the cross-sector fusion of efforts to build a secure digital environment to ensure the integrity of data, the currency of the 21st century. Ultimately the objective is to give students an understanding of the complexity and interdependence of the ecommerce ecosystem and the role cyber security plays in facilitating the free flow of ideas, goods, and services vital for a viable modern society.

Governing the Digital Ecosystem (Fall 2021)

With the emerging diffusion of national power propelled by advances in technology that eclipses traditional centers of power, such as, natural resources, military forces, capital resources, political institutions, and social cohesion it is imperative that a fresh approach to the role played by cyberspace in creating a new power center is understood. Further, it will explore how governments use cyberspace and the tools provided to shape the political landscape through messaging, control of on-line behavior, access to information, and surveillance. This course dismantles the traditional notions of national power and examines the impact that mastery of the digital ecosystem can have in creating asymmetries of power for both state and non-state or sub-state actors. It examines the diverging U.S. and China led development of competing cyber infrastructure with differing standards and protocols. It asks the question of how these systems differ and what is the impact of this competition on the international community. Using qualitative and quantitative tools it will challenge student to analyze the trends developing in this process and to understand the long-term societal implications of this change.

Cyber Ethics and the State (Spring 2022)

The course examines the impact on human society of the rapid evolution of digital surveillance tools, artificial intelligence, internet of things, and the increase of computing power. It asks the question of whether technology should drive the course of human progress or will society engage in a value laden conversation about role of human agency in that process. Further, we bring the question of ethics into an environment that seems to operate under its own imperative. As we are told that at some point computers and smart machines empowered through artificial intelligence will achieve self-awareness. We will look at the institutions necessary for establishing the foundations of an open dialog to determine the appropriate role for these technologies in society. The course engages students in a debate as to whether or not we can build a technological future based on an ethical framework and if so, how we are to go about it. Through the use of case studies and selective readings from a variety of sources (open source reports and studies, books and writings of digital practitioners) the course guides students through the challenges facing society and its institutions in charting the direction and pace of change in a manner constant with a set of values that approach this change within an ethical framework that honors the human person.

Comparative Study of Internet Regulatory Frameworks U.S.-EU (Spring 2022)

This course examines the different approaches to internet governance in terms of privacy, platform regulation, data protection, risks, government oversight, and legal liability. take an enterprise level holistic perspective of cyber security. The purpose is to explore the emerging regulatory divergence between the U.S. model and the European model within the context of a global eCommerce landscape.

Cyber Espionage, Piracy, and Propaganda (Fall 2017)

This course looks at the increasing currency of cyber initiated conflict as the central component of state power. With close attention paid to the rise of social media, diplomacy, cyber espionage, cyber managed propaganda, and the piracy of intellectual property by state and non-state actors, the course traces the growing complexity of the cyber landscape as an arena of competition between nation states for global dominance. Through the use of case studies and selective readings from a variety of sources (government policy reports and directives, cyber security industry studies, social media posts, non-governmental organizations, academic research papers, and intergovernmental organizational research and policy papers) the course guides students through the emergent quality of the ubiquitous nature of the cyber domain and the multifaceted response to the challenge as it impacts international relations.

International Peacekeeping (Fall 2018, Fall 2019, Fall 2020)

This course looks at the growth and development of the international architecture of institutions designed to deter, prevent, and resolve conflicts between nations in the aftermath of the destruction of the Second World War. The course employs a case study approach examining the paths to peacemaking by looking at pivotal moments in international affairs that brought about significant changes in the relations between countries. Specifically, we will examine the Good Friday Agreement (April 10, 1998) which brought peace to Northern Ireland, the Camp David Accords (September 17, 1978)

which resolved the conflict between Israel and Egypt, the Dayton Accords (December 14, 1995) bringing the conflict between the warring parties in Bosnia and Herzegovina to a conclusion, and current UN peacekeeping operations. The current framework for international conflict resolution is explored in relation to the challenges of building sustained support for current and future negotiations and peacekeeping. Part of the course will look at, international law through multilateral and bilateral treaties that incorporate conflict resolution mechanisms. Ultimately, the course is designed to develop an understanding and appreciation for the scope and complexity of the diplomacy involved in making peace and keeping it.

Cyber Crimes and Computer Forensics (Summer 2015, 2016, 2017)

This course examines the growth and scope of computer forensics and security as it impacts business processes, personal privacy, intellectual property, risk analysis and

integration into enterprise security planning and implementation. It explores the nexus between corporate governance and business processes in a global economic environment taking into account risks posed by competitors, insider threats, nation states, and non-state actors. In the course, we demonstrate the use of computer forensic investigative tools and processes that can determine where and how information breaches occur.

Organizational Resilience (Fall 2017, Fall 2018, Summer 2019, Fall 2019, Summer 2020)

This course explores the effectiveness of various risk mitigation and recovery models as the integral aspect of organizational resilience. It examines the composition of cyber incident response teams (CIRT) in managing computer incidents in achieving organizational objectives. It compares and contrasts various models of risk mitigation and incident recovery with close attention directed toward sector specific and regulatory imperatives that inform those models. Students have the opportunity to adapt risk analysis to mitigation and recovery strategies to determine the right fit for a specific organization as determined by business operations scope and complexity of the risk environment. Further, it explores the nexus between corporate governance and business processes integration into enterprise security planning and implementation as it pertains to organizational resilience.

Assistant Director/Information Systems Security Officer for the Houston Passport Agency: Chief operations officer responsible for strategic planning, policy formulation, program oversight, management, safety and security, employee development, operational execution, and business process analysis. Direct management of all day-to-day operations

of the agency that includes 144 employees both direct hire and contract staff. (Direct Reports during tenure: three Adjudication Managers, Fraud Prevention Manager, two Customer Service Managers, Processing Chief, Operations Officer, two Systems Administrators, and a contract Processing Supervisor).

Provide leadership and management coordination for the information systems, security and safety, adjudication, customer service, and fraud prevention programs. Select, place, and develop employees by hiring/promoting and designing developmental and training programs to meet organizational objectives. Serve as principal internal controls/unit security officer to maintain effective safeguards against fraud, malfeasance, waste and misappropriation and to assure the safety and security of agency personnel and the visiting public.

Major Accomplishments (by function):

Unit Security Officer – Provide leadership and direction for the Diplomatic Security (DS) Site Security Manager (SSM) and a unit of five contract Uniform Protection Officers (UPOs) to ensure compliance with headquarters/contractor post orders. Serve as principal liaison with Federal Protective Service (FPS) police, local first responders; Houston Police Department (HPD) and Houston Fire Department (HFD) as it relates to security and safety of customers and employees. Serve as principal agency contact with headquarters staff for policy compliance for security requirements.

- Elected as Chairman of the Facility Security Committee (FSC) and serving from 2008 – 2012. Established first Law Enforcement Subcommittee to coordinate all tenant law enforcement agencies active shooter responses to avoid blue-on-blue fratricide.

Information System Security Officer - Ensure integrity of the agency’s automated computer processing systems. To provide training on systems security and ensure compliance with regulations and policies governing the use of automated information systems within the agency.

- In 2005, the Department designated agency assistant directors as information systems security officers (ISSO). At the time, there were no operational requirements for the role. An initial draft was proposed by headquarters. Using knowledge of mission requirements and the application of information systems at an operational level, I redrafted the scope and parameters of the position at the local level. My draft was largely accepted and became the standard for the system-wide organization.
- Conduct annual cyber security training for agency staff.
- Ensure employee compliance with web-based training requirements on cyber security.
- Conduct monthly audits on systems permissions and employee access using propriety system monitoring tools.
- Took corrective action for information system security breaches.
- Reported security violations to the Department’s Computer Incident Response Team (CIRT) and institute corrective recovery measures.
- Took local corrective action in response to CIRT active monitoring in the event of malicious code detections.
- In 2009 I revised the standard to include a role for a regional ISSO which again was accepted as overall standard for the organization.

Chief Operations Officer - Provide leadership and management coordination for the information systems, security and safety, adjudication, customer service, and fraud prevention programs to ensure effective operational coordination and integration. Select,

place, and develop employees by promoting and designing developmental and training programs to meet organizational objectives.

- Managed the growth and expansion of the agency from 43 employees in 2000 to 144 employees in 2013. This includes growth in all major program areas – adjudication, anti-fraud, processing, and customer service.
- Engineered process improvements resulting in per capita performance that rated third out of 26 agencies and first out of agencies that accept applications through a public counter in 2013.
- Suggested a contractor oversight and compliance survey that was accepted and implemented system-wide in 2010.
